In the spirit of building the next generation of Louisiana Access to Justice leaders, Adams and Reese is proud to welcome Loyola University New Orleans College of Law Student Annie Lemoine as its inaugural Louisiana State Bar Association Access to Justice (ATJ) Developing Leadership Intern. Lemoine, a second-year law student, was selected out of numerous, excellent Loyola Law applicants to participate in the first-year program, a first of its kind in the country created by the Louisiana Access to Justice Commission of the Louisiana State Bar Association (LSBA). For the duration of the five-week-long internship, Lemoine will work directly with judges and legal service providers to gain knowledge pertaining to the unmet civil legal needs of Louisiana's indigent population.

Adams and Reese is one of four prominent New Orleans law firms sponsoring the Summer 2016 ATJ Developing Leadership Intern Program. Held over a five-week period from May 23 to June 24, 2016, the program offers a rising 2L law student from each of Louisiana's four law schools the opportunity to learn about Louisiana's civil justice community first-hand. Each week, the interns will focus on the various civil legal needs of low-income people, the ways in which organizations within the justice community address those needs, and how ATJ services increase the quality of life of those served. ## New Orleans Attorneys Provide Pro Bono Representation to Orleans Public Defenders Office

Three New Orleans attorneys will represent the Orleans Public Defenders (OPD) office on a pro bono basis in connection with a class-action lawsuit filed against OPD in January. The lawsuit came on the heels of OPD's announcement that it would begin refusing certain felony cases due to lack of funding and a shortage of attorneys qualified to provide competent defense in the cases. OPD announced it would instead focus on cases involving lesser felonies. The lawsuit, filed on behalf of indigent defendants in the Federal Middle District Court of Louisiana, alleges that the lack of legal representation violates defendants' Sixth Amendment rights. Partner Justin Schmidt, Associate Jennifer Barriere and Pro Bono Paladin Mark Surprenant will represent OPD on a pro bono basis in the lawsuit. Read more

Attorneys in Baton Rouge have volunteered at several pro bono events and clinics through the Baton Rouge Bar Association Pro Bono Project's Ask-A-Lawyer and Thirst for Justice programs.

Birmingham Of Counsel Richard Carmody has been named the Adams and Reese National Appleseed Senior Pro Bono Fellow continuing to assist the organization in communicating consumer commercial law issues to the nonprofit's network of 17 public interest justice centers in the United States and Mexico.

#### Columbia

Columbia attorneys have hosted two pro bono-thons this year through South Carolina Bar Public Services Division using a new interface that allows questions from the community to be asked and answered in real-time.

Houston attorneys continue to work on several pro bono assignments through the Houston Volunteer Lawyers Program providing legal services in civil matters for Houston's needy citizens who cannot get help through other legal aid programs and is based on income eligibility..

#### **Jackson**

Jackson Partner Laura Rose and Associate Ben Morgan collaborated on a pro bono case that ultimately restored guardianship to a mother who had been struggling. "Things had settled back down to a normal family situation, and we were able to help maneuver it through the courts, so that everything came out happily in the end," Rose explained. "It was very gratifying."

#### **Jacksonville**

Jacksonville Litigation Partner Tim Volpe represented the Jacksonville Humane Society (JHS) in an eminent domain proceeding. Their efforts were integral to achieving just compensation for the taking of the property. The funds paid to JHS are now being applied to the construction of a new facility to replace the shelter that burned down in 2007. St. Petersburg Partner Jim Dickson also aided JHS in its efforts to construct their new facility by representing the shelter in contract negotiations with construction contractors.

#### Memphis

Memphis attorneys continue to work on several pro bono matters through Memphis Area Legal Services, Inc. (MALS), helping provide free legal assistance, community education and representation in civil matters to several counties throughout Tennessee.

#### Mobile

Mobile Partner Jannea Rogers serves as the firm liasion to the ABA Military Pro Bono Project which accepts case referrals from military attorneys to provide service members legal assistance. The Project is also the platform for Operation Stand-By, through which military attorneys may seek attorney-to-attorney guidance.

#### **Nashville**

Nashville attorneys continue to work through the Nashville Pro Bono Program, which is coordinated by the Legal Aid Society of Middle Tennessee and The Cumberlands, helping to aid low-income families in numerous civil cases.

#### **New Orleans**

Pro Bono Paladin Mark Surprenant received the Louisiana State Bar Association's 2015/2016 President's Award in recognition of his outstanding contributions that have made a substantial impact on the Louisiana State Bar Association (LSBA) and the legal profession. He also received an LSBA Pro Bono Century Award on May 24, 2016 for donating more than 100 hours of pro bono service in 2015 with the LSBA.

#### Sarasota

Sarasota Partner in Charge Jason Gaskill and Special Counsel Laura Bauman successfully defeated an attempted hostile takeover of a local conservation not-for-profit Board by its former executive director. The volunteer members of the Board were faced with various fiduciary allegations and an attempted injunction action. As a result of the approximately 150 hours of pro bono work performed by Gaskill and Bauman, the not-forprofit Board uncovered substantial discrepancies in the financial records provided by the executive director. Ultimately, the executive director was removed, and the attorneys successfully facilitated the unification of two distinct factions into a single cohesive Board of Directors.

#### St. Petersburg

Through pro bono services, Partners Andrew McBride and Jim Dickson obtained a judgment and collected \$5,000 for an elderly resident who had sold his car to a relative who subsequently refused to pay. In a separate pro bono matter, Dickson obtained a determination of no probable cause by the Florida Commission on Ethics for a claimed ethics violation brought against a local city commissioner. The commissioner had served as executive director of a neighborhood family center, which received funds from the city.

Attorneys in Tampa continued working with the Are You Safe organization to provide legal representation for indigent victims of domestic violence, assisted in securing permission for the expansion of a local school and secured a successful appeal to correct an erroneous ruling on back child support for a disabled parent. Work has also begun working with Wills for Heroes and the local Guardian ad Litem program.

#### Washington, DC

Jeff Brooks, Washington, DC Partner is working with Mark Surprenant, New Orleans Partner and Pro Bono Paladin, on a task for the Louisiana Access to Justice Committee to help secure appropriate funding in Congress for the Legal Services Corporation, which provides free legal services to low-income individuals and families across Louisiana and elsewhere in the
